3. The results section needs to be more focused and structured. For instance, the research findings can be summarized briefly in the form of key points or significant findings that are more explicitly stated.
4. The abstract should end with a clearer conclusion about the outcomes of the research. Currently, the ending repeats previous information rather than offering a concise summary of the conclusions.
5. If relevant, highlight the importance of this research for future developments or improvements, particularly regarding the use of mediation in election disputes in Indonesia.
